Only use this form to transfer mutual fund shares held within your brokerage account if the receiving firm is ACAT eligible. Do NOT use this form for retirement accounts or to transfer between Fidelity accounts. To allow adequate time for processing, Fidelity should receive this form at least two weeks prior to any deadline (e.g., year-end). Type on screen or print out and fill in using CAPITAL letters and black ink. If you need more room for information or signatures, make a copy of the relevant page.

One authorized signature is required unless you have a Mutual Fund Account (the account number begins with a 2 followed by two letters) in which case all owners must sign.

A Medallion signature guarantee is required if the transfer is over \$18,000.

If the form is completed at a Fidelity Investor Center, the Medallion signature guarantee is not required. You can get a Medallion signature guarantee from most banks, credit unions, and other financial institutions. A notary seal/stamp is NOT a Medallion signature guarantee.
